### **Economic Sanctions Will Kill Tens of Thousands of Innocent Iranians**

*[...] Officially, U.S. economic sanctions do not include medicine. But in practice, medicine is subject to sanctions. The reason is twofold: no pharmaceutical company producing critical medicines is willing to sell its products to Iran for fear that the Treasury Department might find some small technical or administrative errors in their applications and go after them with a vengeance. [...] The second reason is practical. Even if a pharmaceutical company was willing to export its medicines to Iran, Iran's banking system has been effectively cut off from the rest of the world. At present, there is no mechanism to pay for the imports except through the personal accounts of individuals in Europe or elsewhere. This avenue was used during the crippling sanctions that President Obama imposed on Iran in the early 2010s, but it resulted in incredible corruption, theft, and the importation of expired medicines. As a result, the Rouhani administration has so far avoided this route.[...]"*

*[...] A shortage of medical devices is another factor. In this case, the problem is even more complex because some devices are perceived as having a dual use—that is, they could have military as well as medical purposes—and their export to Iran is banned under all circumstances. Asr-e Iran, a reformist website in Iran, reported a list of medical devices that thousands of cancer patients need and that are unavailable in northwest Iran. The list only goes to show the mind-boggling nature of such shortages.[...]"*

*[...] Beyond the medical field, there are several other ways in which U.S. sanctions are hurting ordinary Iranians every day. Another aspect is the shortage of some foodstuffs. As with medicines, the export of wheat, barley, corn, and other food items to Iran is not officially sanctioned, but major global traders have halted their supply agreements with Iran because the sanctions have paralyzed the banking systems required to secure payment. Two Iranian ships contracted to carry corn, soybean and meat to Iran were stranded in Brazil because Petrobras, the Brazilian oil company, refuses to supply fuel to the ships, apparently in fear of running afoul of U.S. sanctions. After Brazil's Supreme Court ordered Petrobras to supply the ships with fuel, they finally left Brazil.[...]"*

[...] The United States is deliberately making the situation worse partly by organising a pirate seizure of the Iranian tanker in Gibraltar to strengthen the US military presence in the Gulf area under the pretext of "ensuring freedom of navigation." At the same time, other countries are being dragged into provocative schemes, even those that basically have nothing to do with this region. They are already being organised into some kind of "naval coalition." This is a favourite device in recent years – instead of building up forces to ensure peace and stability based on international law, they are creating obscure coalitions with vague powers and rights that are not supported by any legitimate authority, that simply pursue the opportunistic interests of a certain group of countries. This naval coalition is apparently aimed at exerting pressure on Iran rather than ensuring peace; unfortunately, as we understand it, the United States is playing the leading role here.

As a reminder, before the United States unilaterally withdrew from the agreement that ensured the peaceful nature of the Iranian nuclear programme, shipping and oil traffic through the Strait of Hormuz was smooth and stable. There was no need to form any coalitions to ensure security until the Americans began to artificially escalate tensions.[...]"

*[...] Even if the EU does have sanctions seeking to preclude an Iranian ship from delivering Venezuelan oil to Syria, the EU or its member states have absolutely no right to impede the passage of an Iranian ship through the Strait of Gibraltar in enforcement of those sanctions. Anymore than Iran could declare sanctions against Saudi oil being delivered to Europe and close the Straits of Hormuz to such shipping, or Indonesia could declare sanctions on EU goods going to Australia and close the Malacca Strait, or Russia could declare sanctions on goods going to Ukraine and close the Strait of Kerch.*

*There are two circumstances in which the U.K. could intercept the Iranian ship in the Strait of Gibraltar legally. One would be in pursuance of a resolution by the UN Security Council under Chapter VII of the UN Charter. There is no such resolution in force. The second would be in the case of a war between the U.K. and Iran or Syria. No such state of war exists (and even then, a naval blockade must be limited by the humanitarian measures of the San Remo Convention). [...]”*
