- Between 1980 and 2018, the tax obligations of America's billionaires, measured as a percentage of their wealth, decreased 79 percent.
- Between January 1, 2020 and April 10, 2020, 34 of the nation's wealthiest 170 billionaires have seen their wealth increase by tens of millions of dollars. Eight of these billionaires Jeff Bezos (Amazon), MacKenzie Bezos (Amazon), Eric Yuan (Zoom), Steve Ballmer (Microsoft), John Albert Sobrato (Silicon

Valley real estate), Elon Musk (Tesla and SpaceX), Joshua Harris (Apollo Global Management), and Rocco Commisso (Mediacom) — have seen their net worth surge by over \$1 billion.

- The Jeff Bezos wealth surge is unprecedented in modern financial history and varies greatly day by day. As of April 15, his fortune had increased by an estimated \$25 billion since January 1, 2020. This is larger than the Gross Domestic Product of Honduras, \$23.9 billion in 2018.
- Billionaire wealth rebounded quickly after the 2008 financial crisis, taking less than 30 months to attain its pre-meltdown levels. Between 2010 and 2020, U.S. billionaire wealth increased 80.6 percent in 2020 dollars, more than five times the median wealth increase of 15.1 percent for U.S. households over the 2010 to 2016 years, based on most recent available data.
- The billionaire share of America's increased wealth has risen throughout the past four decades. Between 2006 and 2018, nearly 7 percent of the real increase in America's wealth went to the country's 400 wealthiest households. [...]"

In the United States and globally, these have become the "Billionaire Years." Billionaires dominate our politics, culture, and economy. Our media hail their philanthropic gestures and treat their utterings as the pronouncements of modern-day monarchs. Each January, these royals assemble in Davos, dropped down from the skies in thousands of private jets.

We have watched billionaires deploy their wealth for political purposes and buy their way onto presidential debate stages. Two billionaire candidates for the Democratic presidential nomination spent more than \$1.2 billion in quixotic runs for our nation's highest office. Other members of America's top 0.1 percent wield enormous influence down ballot in U.S. congressional races and state races.

We have also watched the expansion of billionaire philanthropy and the mushrooming of private foundations and donor-advised funds. Philanthropy in the United States has become increasingly "top heavy," with almost all the growth in giving over the past 15 years coming from the super-rich. This growth masks a troubling trend: Donations by low-income and middle-income givers have been steadily declining.

This spring, in the face of a global pandemic, headlines are trumpeting the beneficence of billionaires who are donating what amounts to as little as 0.00001 percent of their fortunes to help their fellow humans in need. Forbes magazine has even created an online tracker to record the billionaire "agents of change" and their seemingly selfless acts.²

Meanwhile, the hidden wealth problem grows as billionaires pay millions to the Wealth Defense Industry — an army of lawyers, accountants, and wealth managers — to hide their collective trillions. Our global billionaire class, by one estimate, has hidden over \$21 trillion in offshore tax havens, trusts, and shell companies.³ [...]"

"In light of a recent U.S. State Department arms control compliance report highlighting Iran's growing "uranium enrichment activities and stockpile of enriched uranium." this report presents recent Iranian breakout estimates and compares them to pivotal historical ones, where breakout is defined as the time Iran would need to produce 25 kilograms of weapon-grade uranium (WGU), enough for a nuclear weapon. As of late February 2020, the breakout estimate is 3.8 months, with a range of 3.1 to 4.6 months. This estimate is based on an Institute breakout calculator, utilizing modified ideal cascade calculations, adjusted with results from an earlier multi-year program of complex computer simulations of Iranian breakout, conducted in collaboration with centrifuge experts at the University of Virginia, and supplemented by operational data on Iranian centrifuges. The breakout estimates result from Iran's installed enrichment capacity and its stock of low enriched uranium (LEU), as reported by the International Atomic Energy Agency (IAEA) in its quarterly reports on Iran. A significant development is that Iran is at the threshold of having enough LEU to move from a four-step enrichment process to a three-step one, allowing a significant reduction of breakout times, a phenomenon referred to in the media as a "key threshold" or "enough LEU for a nuclear weapon." A potential covert enrichment plant utilizing 3000 IR-2m centrifuges is also assessed, giving a breakout of 3.1 months. The Annex to this report contains a summary of Iran's stock of low enriched uranium, based on the IAEA's most recent quarterly report on Iran, summarizing the situation as of late February 2020 and identifying which of the LEU stocks are used in the breakout calculations.[...]"

"[...] Even before COVID-19, Iran's health system was feeling the effect of the sanctions.3 Their impact is now severe because they restrict the government's ability to raise funds or to import essential goods. Of the ten countries with the highest number of recorded cases of COVID-19 to date, Iran is the poorest.2 In 2019, Iran had the lowest rate of economic growth (-9.5%) and highest rate of inflation (35.7%) recorded in the country for the past 20 years. This financial situation makes the funding of adequate prevention, diagnosis, and treatment of COVID-19 impossible, and the country cannot take the same measures adopted in other countries to strengthen responses, such as paying the full cost of obtaining treatment.3 Essential medicines and medical equipment are technically exempt from sanctions, but their availability is restricted by the effect of sanctions on the commercial sector, reducing manufacturing and trade capacity, and on foreign exchange. Consequently, although approximately 184 000 hospital and primary health-care staff are working to fight COVID-19, their efforts are thwarted by shortages of test kits, protective equipment, and ventilators.
